# Morningstar Category Grouping Changes – October 31, 2025 Announcement

This announcement relates to Phase 2 of the changes we are making to our category grouping methodologies and important updates related to their implementation and release timeframe.

## What's Changing?

The changes to the current Global Broad Category Groups are being made to update them to reflect our best thinking in broad groupings of fund types, with some changes also being made for maximum compatibility with the new Morningstar Category Groups.

### **Next Steps and Client Action Needed**

Below we provide more details on these changes and describe what clients will need to do between now and October. Please use this period to review and prepare for the updates by October 31, 2025. These enhancements are designed to make your analysis more intuitive and powerful.

## What will change on October 31?

#### Below details the steps we are making for the Global Broad Category Group field updates:

- 1. We will re-name the Global Broad Category Group field to Morningstar Category Broad Group.
- 2. We will rename and change identifiers for several of the options in that field.
- 3. We will consolidate Commodities and Property into a single Morningstar Category Broad Group named Real Assets.
- 4. We will re-map funds from each Morningstar Category Group into Morningstar Category Broad Groups based on the new broad grouping schema.

Table 1 shows the changes that will occur on October 31<sup>st</sup>, 2025, to the current Global Broad Category Groups, which will be called Morningstar Category Broad Groups.

For any processes currently relying on Global Broad Category Groups, clients will need to update their systems to account for the updated identifiers, names, and mappings detailed in this notification. If clients do not make these updates prior to October 31, 2025, any systems currently relying on Global Broad Category Groups will not work properly.
